## Letter from the Editor

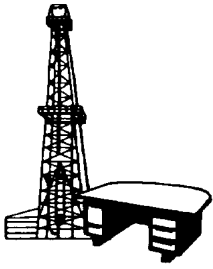
*And just like that, it's February! I certainly hope everyone is staying warm and safe with this winter weather we are currently experiencing.*

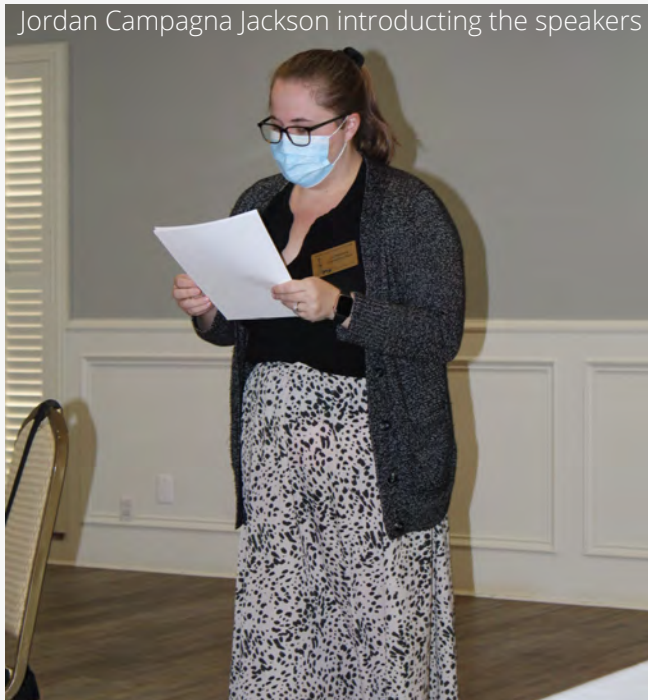

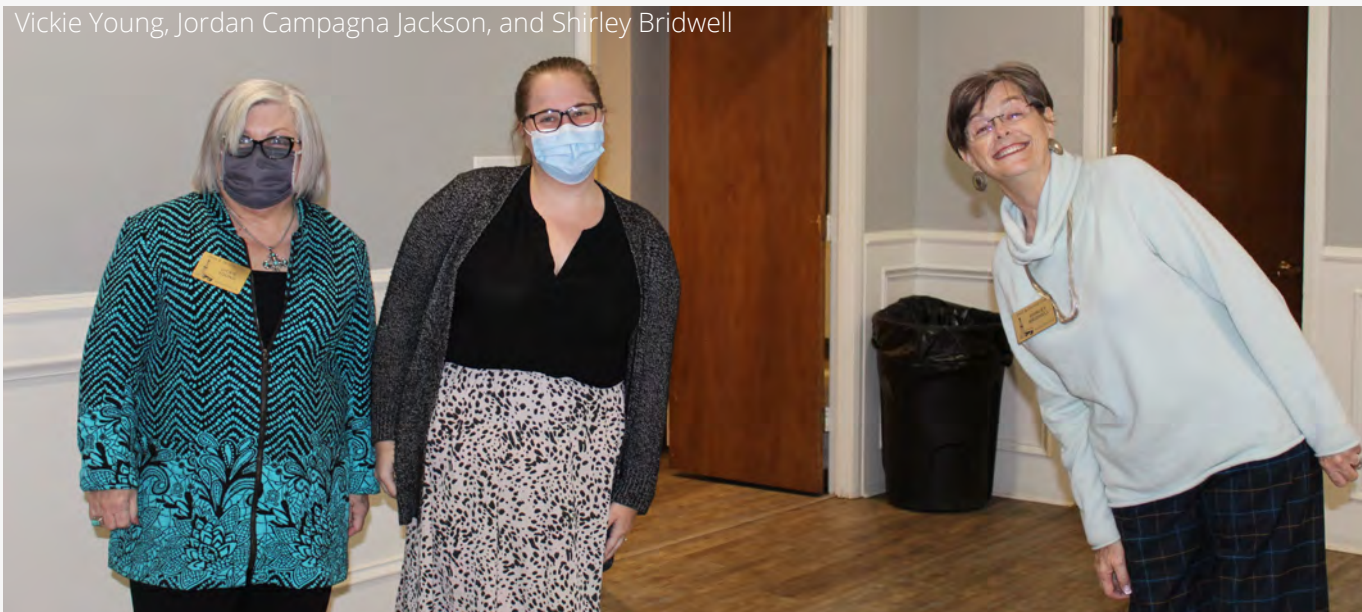

## Oil industry rebounds in 2021; forecasters predict solid 2022

Covid-19 was a major factor in the decline of demand for energy in 2020 and it sent shock waves throughout the oil and natural gas industry. The price of oil and natural gas crashed through the floor and ended in some areas in negative territory during April 2020.

Companies cut capital expenditures and did everything they could to prevent bankruptcy. Some made it, but many did not.

By January 2021 oil prices rebounded to \$60 per barrel and the future looked much better.

Actually, many oil and gas exploration companies did very well. ExxonMobil and Chevron came back making a profit after reporting a loss in two quarters in 2020. ExxonMobil's stock rose from 47 in January 2021 to 71 this week. Chevron's stock rose from 92 a year ago to 127 this week.

Some of the smaller independent companies did even better. EOG Resources, based in Houston, witnessed its stock increasing from 60 to 102, and Pioneer Natural Resources, based in Irving, experienced similar growth from 115 a year ago to 204 on Wednesday.

The Wall Street Journal recently reported on the industry's good fortune in a story with the headline stating "S&P 500's Energy Sector on Pace to Hit Record Annual Gain."

The newspaper reported in its January 8-9 edition the S&P 500 Energy sector had the largest gain of any sector at 10.62% followed by Nymex natural gas at 4.99% and Nymex crude oil at 4.91%.

The state of Texas benefitted, too. The Texas Oil & Gas Association reports during fiscal year 2021 the state and local governments received \$15.8 billion in taxes and royalties, an increase of about 20%.

Quite a turnaround from the dismal economic conditions just a short time ago. And the Energy Information Administration reported this week crude oil and natural gas prices should remain strong in 2022 as global demand rises.

"Global oil consumption outpaced oil production for the six consecutive quarters ending with the fourth quarter of 2021, which has led to persistent withdrawals from global oil inventories and significant increases in crude oil prices," EIA stated in its Short-Term Energy Outlook released Jan. 11.

EIA forecasts Brent crude oil will average \$75, and West Texas Intermediate will average \$71 in 2022.

EIA believes the average price of gasoline will be around \$3.06 compared to the average price in 2021 of \$3.01.

"U.S. crude oil production in 2021 averaged 1.1 million b/d lower than the annual record high of 12.3 million b/d set in 2019. We expect annual average U.S crude oil production will increase to 11.8 million b/d in 2022 and to 12.4 million b/d in 2023," EIA stated.

Natural gas will be a major source of generating electricity in the U.S. accounting for 35% followed by coal (22%), nuclear (20%), wind and solar (13%) and hydropower (7%).

Natural gas prices at Henry Hub will average \$3.79 per million British thermal units in 2022 down for the \$3.91 average in 2021, according to EIA's forecast.

# Oil Jumps Past \$80

Global energy prices are moving upward.

Crude oil, gasoline, and natural gas are all higher than at the beginning of 2022. Crude oil is up 13% from \$76 on Jan. 3 to \$86 on Jan. 18, but gasoline is up only 0.7% from \$3.28 to \$3.30. Natural gas has increased 7% from \$3.815 to \$4.283, according to data from the Energy Information Administration.

Goldman Sachs Group Inc. stated recently it expects crude oil to trade at \$100 per barrel during the third quarter of this year.

Demand for petroleum products continues to grow while supplies struggle to keep pace.

Governments around the world are reacting differently to the pandemic than a year ago when many leaders implemented lockdowns. Economic activity declined rapidly as did demand for energy. As lockdowns were lifted, demand rose.

On the supply side, crude oil production declined as the oversupply drove price down.

The Organization of Petroleum Exporting Countries (OPEC) agreed to cut production as did other countries, which included Russia. Later in 2021, the group agreed to increase production by 400,000 barrels per day, but OPEC has not been able to achieve that goal. Analysts estimated OPEC was able to add only 90,000 barrels per day in December. Numerous problems have been reported regarding production in Africa, Russia and Libya,

The U.S. became the world's largest oil producer in late 2019 at 13 million barrels per day. The production declined to 11 million barrels per day, but the Energy Information Administration expects production to come back this year if demand and price remains strong.

The situation in China, one of the largest consumer and importer of oil, remains complicated. China has taken a zero-Covid policy. Complete cities have been in lockdown. However, this policy will be tested as competition in the Winter Olympics begins on Feb. 4 and the Lunar New Year celebrations, which occurs in a few weeks. If there is a major outbreak following these events, demand in China could decline.

The global demand trend points to continued expansion of economies around the world with the U.S. gross domestic product (GDP) increasing 4.3% in 2022, according to EIA. However, continued high levels of uncertainty created by the pandemic raises questions about global energy consumption.

# Volatile natural gas prices hinder future progress

Natural gas has been called the fuel of the future for quite some time.

It is available in large quantities.

It has a complex infrastructure of pipelines, compressors and utilities to deliver massive amounts to consumers.

It has an exceptional high energy content compared to other energy sources, such as coal.

It is produced in America by Americans, creating jobs and economic wealth.

Its major disadvantage: price volatility.

Natural gas came on the scene as a major energy source about 20 years ago, but it took some 30 years before that to convince federal lawmakers of its value. Before 1978, the federal government had price controls on interstate gas sales, but intrastate gas (gas produced and consumed in the same state) was free of federal price controls and there was plenty of gas for the intrastate market but shortage interstate.

Members of Congress decided the entire nation should have access to this wonderful resource and passed the Natural Gas Policy Act of 1978, which slowly deregulated natural gas prices, allowing it to flow freely across state lines.

In 1986, the New York Mercantile Exchange (NYMEX) began trading natural gas futures and changed the pricing structure of the industry forever.

In most instances, exploration companies drill the wells, produce the gas and sell it to a pipeline company that transports it to a utility for distribution to consumers. The exploration company and pipeline negotiate a contract specifying the volume to be delivered and the sale price, which usually is based on an average price sold on NYMEX or some other distribution point.

Natural gas prices are a function of market supply and demand. Increases in natural gas supply generally result in lower natural gas prices, and decreases in supply tend to lead to higher prices. Increases in demand generally lead to higher prices, and decreases in demand tend to lead to lower prices. In turn, higher prices tend to moderate or reduce demand and encourage production, and lower prices tend to have the opposite effects.

Natural gas prices also can be affected by production and storage quantity, economic growth, and variations in weather.

Texas recently experienced historic low natural gas prices in April 2020 when spot prices dropped into negative territory several times because demand dropped dramatically during Covid-19 lockdown. Just about a year later (February 2021), prices went through the roof during a winter storm that sent demand up and supply could not keep up.

Natural gas peaked at the Houston Ship Channel at \$400 per mcf on Feb. 15 and \$375 per mcf at Katy near Houston. In West Texas, natural gas peaked at \$204 at Waha on Feb. 15. Meanwhile, gas traded at \$2.91 per mcf on NYMEX that day and \$23 at its delivery point of Henry Hub in Louisiana. The price crisis started on Feb. 12 and concluded of Feb. 21.

Natural gas is an amazing energy source, but price volatility is a problem that has just about everyone searching for a solution.

# Reports Indicate Renewed Vitality in Oil and Gas Industry

Two reports were released recently highlighting the increase in economic activity in the oil and gas industry in Texas in 2021 with anticipation of even more advancements this year.

The Texas Petro Index (TPI) reports a 28.8% increase in activity last year, and the Dallas Fed Energy Survey revealed expectations of continued growth.

TPI hit bottom during January 2021 and expanded each month as crude oil and natural gas prices rose, along with the drilling rig count, production, and employment.

The Dallas Fed surveyed 134 company officials in December and expressed confidence in crude oil and natural gas prices during 2022. Responses ranged from \$50 to \$125 per barrel for oil (averaged \$75) and averaged \$4.06 for natural gas.

"Assuming continued steady growth in upstream activity levels in Texas in the coming year, the TPI is on track to reach and surpass the previous peak in late 2022," Petroleum Economist Karr Ingham, creator and author of the TPI, said.

Crude oil prices rose 40% year-over-year (from \$35 to \$50), and the December monthly average of \$67.47 was up by more than 56% compared to December 2020. Monthly posted crude oil prices averaged as high as \$77.12 in October 2021, after averaging as low as \$14.68 in April 2020. The 2021 fourth quarter average crude oil price was the highest since the third quarter 2014.

Natural gas prices paid to producers averaged \$5.79/MMBtu for the year, the highest annual average since 2008, Ingham said. "While natural gas prices were already trending higher in 2021, the upward price spike in February 2021 in response to Winter Storm Uri pushed the average significantly higher," he said.

The Texas statewide rig count increased each month last year to a high of 275 in December, which is a strong recovery from the record low of 105 rigs at work on average in August 2020.

"Nearly 18,600 direct upstream oil and gas jobs have been added thus far in the current expansion, including nearly 16,500 over the last year," Ingham said. "However, that follows the loss of over 83,000 jobs over the course of the entire contraction, 63,000 of which were shed during 2020 alone. As of December, estimated upstream industry employment in Texas was 175,925, compared to the low point of 157,330 in September 2020, and the most recent cyclical employment peak of over 240,000 jobs in December 2018."

Crude oil production is increasing in Texas, exceeding 5 million bpd in December according to preliminary estimates, Ingham said. Crude oil production reached record levels in early 2020 at over 5.4 million bpd before declining by 22% from March to May, a decline of nearly 1.2 million bpd.

"Record or near-record production for crude oil and natural gas in Texas ... tells a fantastic story about what Texas oil and gas producers from large to small have been able to achieve," said Ingham. 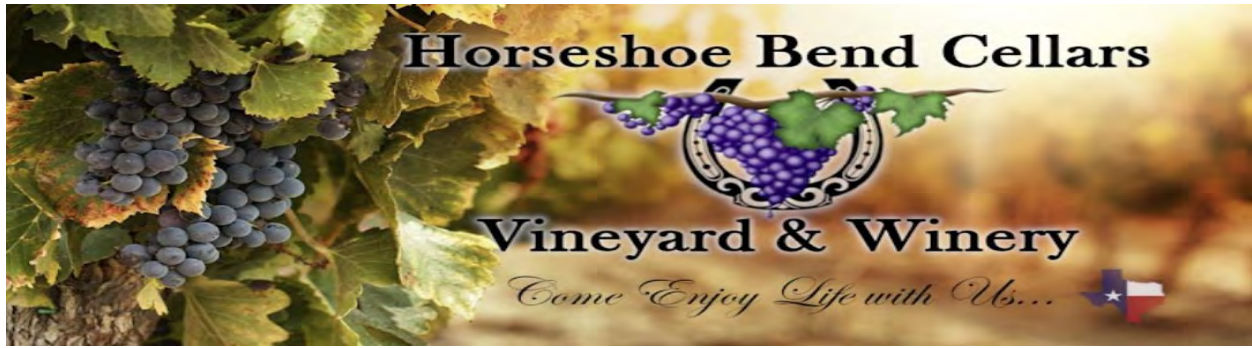
### **Midwestern State University—Kimbell School of Geosciences**

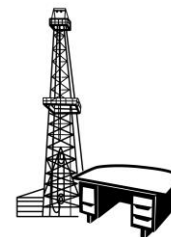
