Energy News and More

This week, most of the world's major news is coming from the United Kingdoms of Great Britain, Wales, Scotland, and Northern Ireland. On Tuesday, September 6th, Queen Elizabeth II formally accepted the resignation of Boris Johnson as Prime Minister and acknowledged Liz Truss as the 15th Prime Minister during her 70-year reign.

At age 47, Liz Truss has served in Parliament for 12 years holding several cabinet roles within the Conservative government. In the U.K., the public elects members of Parliament from their districts but not the Prime Minister (PM). The political party holding the majority of seats within the legislative body puts its leader forward to serve as the Prime Minister.

According to an article by Anders Hagstrom published by Fox News on Thursday the 8th, Truss ended the U.K.'s ban on fracking implemented in 2019 and opened the door for the sale of domestic gas production amid a European energy crisis with the possibility for the U.K. to increase domestic production as early as March, 2023.

With Russian President Vladimir Putin limiting the country's oil and gas exports to Europe after NATO countries imposed severe economic sanctions on Russia in retaliation for its invasion of Ukraine, the U.K. and other European countries have faced a worsening energy crisis due to their heavy dependence on those imports. The energy crisis has pushed the U.K., along with several of its European neighbors, to reconsider their shutdown of nuclear power plants. Germany made loopholes in its plan to shut down its remaining plants last week and allowed the possibility for two previously shut down units to be re-opened if necessary. Belgium was planning to close two reactors by 2025 but will now keep them open through 2036. France is looking to build an additional 14 reactors over the next several decades.

Overshadowing the change in leadership of its governing body and its change in energy policies, the U.K. sadly announced the death of 96 year-old Queen Elizabeth II on Thursday the 8th and the subsequent accension of Prince Charles to the throne as King Charles III. In the new P.M.'s speech before Parliament on Thursday, Truss acknowledged the Queen's passing saying "Queen Elizbeth II was the rock on which modern Great Britain was built. She was the very spirit of Great Britain, and that spirit will endure." Farewell to a great lady; and, as they are now saying in the U.K., "God save The King".



To Use Electricity or Not To Use Electricity

In the July issue of the Tri-State News, I included an article entitled "What is the Electric Grid" explaining how use of the grid is intended to maintain reliability, flexibility, and economic competition for its members using as my source information provided by CenterPoint Energy, the primary supplier of gas and electric power to Southern Indiana and other areas. CenterPoint is a member of the regional grid operated by Midcontinent Independent System Operator (MISO) and MISO is a member of a national grid consisting of member grids across the country. So far, our area hasn't experienced any emergencies affecting the transmission of power across MISO's grid.

This is not the case in the western states this summer. The California Independent System Operator (ISO) is the grid operator for California and other western states. According to the major news networks, California has been experiencing some of its highest recorded daily temperatures causing ISO to issue a warning of the possibility of implementing rotating outages for the first time in two years. To held alleviate the possibility of such outages, businesses and the general public were urged to raise their thermostats to 78 degrees and to cut any unnecessary power use between the hours of 4:00 PM and 9:00 PM. Among a great many other things, that meant no baking chocolate chip cookies in the afternoon. Should the demand for power exhaust the grid's electric reserves, ISO said it would instruct its member utilities to start imposing rotating outages. The last time ISO ordered utilities to impose rotating outages was for two days in August 2020 when outages affected about 800,000 homes and businesses and lasted anywhere from 15 minutes to about two and one-half hours. Thankfully, this year they got a break in the weather before any outages were necessary.

While the grid supplying California electricity is being stretched to its limits just to supply power to homes and businesses during peak usage hours, California's Air Resources Board approved a ruling requiring all cars, trucks and SUV's sold in the state after 2035 to be free of greenhouse gas emissions like carbon dioxide. All new vehicles sold in the state would be required to run on electricity or hydrogen. The ruling would permit one-fifth of new vehicle sales to be hybrids. Older vehicles would not be affected by the ruling.



It is estimated that 4% of the energy used by 2030 would be needed just to charge the increased number of electric vehicles during the time frame when usage is highest---generally in the evenings and overnight and even greater during the summer months. Where's all this extra energy going to come from? From what I could glean from their website, MISO is not currently partnered with the grid for the western portion of the country.
