Navigating through the Constellation of Desk and Derrick

Good Evening, Members,

The Stars above us - like days of old would lead travelers and mariners around the world toward their destinations and dreams. Today, our Stars are you – the Members of Desk and Derrick. Each one of you are unique in your own way, just like the stars that make up the Constellation of the Association of Desk and Derrick Clubs. We would not be here without our Founding Shining Star, Inez Awty Schaffer, (whose nickname, ironically was "Star") employed at Humble Oil & amp; Refining Company. Her company was founded in 1911, thanks to a giant oilfield discovery at Humble, Texas, four years after the famous 1901 Spindletop gusher.

Ms. Schaffer organized a meeting in New Orleans in 1946 (a few years after World War II), a National Association of women in the petroleum business who as I quote Ms. Schaffer "ebbed and flowed with the tides of the energy and allied industries." Inez Schaeffer was always writing reports about things she knew little about and believed women working for oil companies wanted to see and know more about a Derrick, a Christmas tree and other aspects of the petroleum Industry.

In 1951, Representatives from three other cities gathered in New Orleans to brighten the Desk and Derrick Constellation, to establish the Association of Desk and Derrick Clubs (ADDC) of North America. The Articles of Association were signed by the Presidents of the New Orleans, Jackson, Los Angeles, and Houston Clubs. The combined membership of the four charter clubs was 883 as the stars started growing stronger and brighter. The newly organized group of business women began promoting energy education in the United States and Canada in

1952.

As we are travelling through the Desk and Derrick Constellation, a lot has happened in Desk and Derrick since the 1940's, in the 50's the Logo was established and our Motto was adopted. Moving around the stars, the 60's were a quiet decade, (except for Neil Armstrong walking on the moon among the stars).

In the 70's, North America was dropped from the Association's name, the Fundamentals of Petroleum went on sale, now in our fifth printing. The stars of the 80's were really bright, the Desk and Derrick Educational Trust was established to assist students pursuing degrees in petroleum, energy and allied industries and possibly future bright stars in our Constellation.

The Oil Women of the Year (eventually changed to Energy Person of the Year) and the ADDC Foundation was established to publish and produce educational materials and to sponsor seminars and classes. Delegates at the 1988 Convention approved equitable membership in the Association opening membership to men.

Maneuvering our way into the 90's, the website was established online, and our Mission Statement was adopted. As the Millennium or Y2K appears on the Horizon, ADDC celebrated its 50 th year anniversary in 2001, a proposal of realignment of regions was passed and implemented in 2019, also the first Male President was elected in 2020. Unfortunately, that year Regional Meetings and

Conventions were cancelled or re-scheduled due to the Cosmic Covid Epidemic.

As the Desk and Derrick Constellation is still thriving, some of our stars in our Constellation are starting to dim, therefore, we need to re-focus our telescope and our membership tools to see what can be done to ensure that our stars will continue to shine with in the Constellation.

Some of our shining stars of the Westbank are our Charter Members since 1976, Jo Ann Brown, Judy Guillot, Sylvia Hohman, and Kori Allemand, please stand. Our three ADDC Association Presidents, Judi Adams, Theresa Adams and Angie Duplessis. Would the past Regional Directors and Club Presidents also please stand. I will quote a saying from Inez Schaeffer "If we can achieve what we set out to do, we will not only extend our horizons, they will become unlimited."

And Remember, don't just look at the Stars, Be One!!

- 1. **Can't recruit new volunteers.** How many new volunteers have you had sign up within a month? It's a problem if your nonprofit struggles to find and retain volunteers. Volunteers are like employees: they won't do their best if they feel they're not appreciated. Volunteers want to feel as if they're a part of something big, not a dictatorship.
- 2. **Current volunteers leave or don't show up**. volunteers want to feel appreciated. They also want to be a part of the organization by having their ideas listened to and discussed. If the nonprofit management team ignores volunteers, your organization won't stay open for long.
- 3. **Decisions are hindered by too many decision makers**. If the nonprofit management team puts up obstacles and roadblocks every time something needs to be approved, the organization will fold. There's a time and a place to get approval from the board of directors. However, if qualified volunteers are questioned about this or that all the time, they'll walk and help another organization.
- 4. The organization is outdated, tired and old. How long has the organization been in business? If it's been 10 years or more, it could be time to close or regroup. A nonprofit that hasn't kept up with the changing times is in danger of closing. Why? Because there's one constant in life and that's change. If you're not changing, you're dying.




Renewable Energy

Renewable energy comes from sources that are naturally replenishing and flowlimited; renewable resources are considered inexhaustible; however, they are limited in the amount of energy available.

The major types of renewable energy sources are:

- Biomass
 - Wood and wood waste
 - Municipal solid
 waste
 - Landfill gas and biogas
 - Biofuels
- Hydropower
- Geothermal
- Wind
- Solar

Wood provided nearly all of the nation's energy needs for heating, cooking, and lighting until the mid-1800s. Since the late 1800s, fossil fuels (coal, petroleum, and natural gas) have been the major sources of energy. Hydropower and wood were the most used renewable energy resources until the 1990s. Since that time, U.S. energy consumption from biofuels, geothermal energy, solar energy, and wind energy have increased, reaching record highs in 2021.

In 2021, renewable energy provided about 12.16 quadrillion British thermal units (Btu)—1 quadrillion is the number 1 followed by 15 zeros— for 12% of total U.S. energy consumption. In 2021, the electric power sector accounted for about 59% of total U.S. renewable energy consumption; about 20% of total U.S. electricity generation was from renewable energy sources.

Renewable energy can play an important role in U.S. energy security and in reducing greenhouse gas emissions. Using renewable energy can help to reduce energy imports and reduce fossil fuel use, which is the largest source of U.S. carbon dioxide emissions. The EIA projects U.S. renewable energy consumption will continue to increase through 2050 if current laws and regulations that affect the energy sector, including laws that have end dates, remain unchanged throughout the next 25-30 years.

BATON ROUGE, LA (October 11, 2022) - There has been lots of back and forth lately about Carbon Capture, Usage, & Storage (CCUS). Sadly, two parishes recently passed moratoriums on future CCUS projects. In defense of these parish's decisions, CCUS sounds like something new to them. They don't believe the injection process is proven, don't believe the parishes will be compensated, and have been told that properties can be taken by eminent domain.

To the contrary, injection wells and storage wells have been commonplace for decades in Louisiana. The highly publicized Strategic Petroleum Reserve (SPR) is not a huge tank farm storing oil, but underground storage of the oil in geologic formations. Less known but no less important are the many natural gas storage facilities where billions of cubic feet of natural gas are stored annually in underground geologic formations. Without the storage of natural gas in these reservoirs, the price of natural gas would fluctuate wildly with the changing of the seasons, wrecking the U.S. economy. There are injection wells all over the state that present no issues to the public. Certainly, more education is needed to help these parishes get an understanding of this process. There is fear-mongering and misinformation on this subject that we hope this letter will assist in easing concerns. Companies plan on spending millions and even billions on these projects. Parishes will cash in on Ad Valorem taxes, sales taxes, and local spending from project vendors. The facilities will also create high paying, full-time, local jobs.


These projects will go through an extensive and time-consuming process to be approved and will be highly regulated. As for eminent domain, expropriation can only happen after obtaining permits and a certificate of public convenience & necessity from the Commissioner of Conservation. To obtain that certificate, the Commissioner has to hold a hearing in the parish where the project is located and make certain findings. To expropriate, Conservation would have to approve the project. In most instances, if expropriation would take place, the land itself (i.e., the surface) would not be expropriated, but rather a servitude or right to store at certain depths under the ground. The Carbon Sequestration Act and the right under the act to use eminent domain for carbon sequestration projects is not new. The Carbon Sequestration Act (which included eminent domain rights) was first passed in 2009 and signed by Governor Jindal. Since then, the act was amended in 2021 and 2022 with minor changes. During the Trump administration carbon sequestration was not a high priority, but has now become a bigger deal with the 45Q tax credits.

CCUS will be taking place all over the country, and Louisiana is in a great position to take advantage of these projects. We have perfect geology and an oil & gas workforce ready to step up to the challenge. With the state's industrial plants fully committed to meeting ESG goals, if CCUS is denied here, these plants will be forced to spend billions and create thousands of jobs across the business-friendly border of Texas.

Muffin Tin Potatoes Gratin

A quick and easy potato side dish. Recipe by GnarlyCow Prep Time: 10 mins

Cook Time: 35 mins Total Time: 45 mins

Ingredients

cooking spray

2 tablespoons butter 3 cloves garlic, minced

2 tablespoons all-purpose flour

% cup milk

1/2 cup freshly grated Parmesan cheese

salt and ground black pepper to taste

2 large potatoes, peeled and thinly sliced



Directions

Step 1

Preheat oven to 400 degrees F (200 degrees C). Spray 12 muffin cups with cooking spray or grease with butter.

Step 2

Heat butter in a saucepan over medium heat. Cook and stir garlic in the melted butter until fragrant, about 1 minute. Add flour to garlic mixture; cook and stir until mixture is smooth and thickened, about 2 minutes.

Step 3

Slowly pour milk into flour-butter mixture while continuously stirring with a whisk until sauce is smooth and thickened, about 5 minutes. Remove saucepan from heat and stir Parmesan cheese into sauce until cheese melts from the heat of the sauce; season with salt and pepper.

Step 4

Divide the potatoes among the 12 prepared muffin cups and spoon cheese sauce over potatoes.

Step 5

Bake in the preheated oven until potatoes are tender, about 25 minutes.
