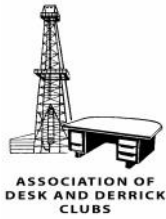

MY FIRST DAY IN THE OIL PATCH

Service Pipeline Company, a subsidiary of Stanolind Oil, has long ago been merged into Amoco. I was hired as a clerk in the Division office in Beaumont, Texas. That division began at the Beaumont-Port Arthur Texas area and covered facilities across Louisiana to the end point at Grand Isle, Louisiana. The district office had three employees, the District Superintendent, the Division Clerk and me, clerk. There were about 100 field employees working across the district. My first day on the job was a shocker! I had never heard oilfield terms and when I started taking notes from the field gaugers some of the terminology blew my mind. In addition to the strange words, in one report the gauger said they had lost Kelly in the hole. I immediately blurted out "Oh, that poor man, how on earth are you going to get him out?" The gauger merely said "Well we have called for a fishing expert." "Fishing? Fishing? You are going to try fishing gear to get him out of that hole?" He started laughing loudly and slowly explained to me that Kelly is a tool used in drilling operations and the fishing gear was another tool that would take hold of the Kelly and pull it back up out of the hole. Phew! Now I was not concerned "for the poor man in the hole." But I was concerned for a "poor animal" when a report stated that they were running a pig in the line. "What? Are you running a poor little pig through that pipeline? How cruel!" "No mam, the pig is a motorized scraper tool that cleans out paraffin from the line." Oh, OK.

About two months into my employment I was becoming more familiar with the terminology and my boss, the District Clerk, told me that he wanted to take me out into the field to familiarize me with the facilities. He said I should wear jeans and flat shoes to go out into the field. Well, the "jeans" that I had consisted of a pair of velvet pants styled as jeans, and the flat shoes were a pair of suede ballet slippers. So -- I meet him on Saturday morning at the office and we start out in his truck to the field. Now, THIS was my first day in the real "oil patch".

Our first stop was at the storage tank farm. The gauger met us there and he told me to follow him and be very careful climbing the stairs up to the top of the tank. This was a 40,000 barrel oil storage tank with a floating top. When we reached the top there was a small platform to stand on and from there the gauger had to jump as far out onto the top to reach the middle where there was a hole and a long line of rope with a weight on the end. (Thank goodness, that type tank is no longer in use in the industry.) He slowly lowered the weight down the hole and then brought it back up. The length of the rope covered in oil was the measurement of the footage of oil, from which he then calculated the size of the tank, and thus the number of barrels of oil in the tank. And, that was the amount of oil in storage that he called in to me daily – for each tank in the field.

We next drove over to the barge facility. There they loaded oil from the pipeline to the barge for transport to the refinery facilities. The guys on the barge were so nice and even cooked a nice lunch for us. The cook gave me some pieces of fat tied to a string so that I could go "crabbing" from the barge. I caught a number of crabs which I immediately gave to the cook. The number of barrels loaded into the barge(s) was called in to me daily.

The next stop was at the rail tank car facility, where they were loading oil from the pipeline into the tank cars. A lot of oil was covering the ground around the loading area. That gauger called in the total number of barrels of oil loaded into the tank cars.

Our last stop was at the docks of the ocean going vessels, where oil was loaded into the ships for distribution to refineries, or to foreign countries. The number of barrels called in to me from there was *TREMENDOUS*.

On Monday my boss told me to write a report on what I saw and learned from the trip to the oil patch. Also, to write a report on anything that I might view as a safety hazard. I was appointed to the district safety board and from my safety report changes were made to some of the facilities.

Now, I have told you about my first day in the "oil patch". Since then, with other companies, and Desk and Derrick Clubs, I have been to many, many sites in the oil patch. I have loved every minute, every year of my association with the petroleum industry, actually over 50 years, and Desk and Derrick since 1969. Thank you dear "Oil Patch".
