# Why Recycling? Author: Donna L Hartig



Recycling plastic is probably the most confusing process in the recycling world. There are just so many types of plastic that we are tempted to throw up our hands and just chuck all of it into the dumpster. That is certainly a shame when so much of it is recyclable.

Plastic is an insanely durable material that resists decomposition, with a presumed life span of over 500 years. It's safe to say that every bottle you've ever used is still somewhere on the planet, although not necessarily in its original form. Plastic bottles get sold, shipped, melted, resold, and shipped again, sometimes crossing the entire planet.

Gary and I started recycling several years ago, sorting the items into labeled bins in the garage and taking them to the collection center on Ford Road when most of the bins have reached capacity. There is another center in the city of Mt. Vernon as well as one that accepts large appliances and other items which might otherwise end up in a landfill. In addition to plastic items, the Ford Road center accepts glass, paper, cardboard, tin and aluminum cans, books, magazines, used motor oil, and more. But, plastic seems to be the number one recyclable.

Recyclable plastics are categorized by numbers 1 through 7, but not all centers accept all the types. The Ford Road center accepts numbers 1, 2 and 5 plus what they call "clam shells" which are the clear, thin plastic cases or trays that sometimes hold strawberries or ready-to-eat sandwiches. In a separate bin, they also accept grocery and dry cleaner bags. By separating the plastic by number/type, they can more easily be re-routed to the facilities where they will actually be recycled into more bottles, bags, etc. Plastic caps can be recycled into park benches and other more substantial items.

In addition to taking plastic to recycling centers, one of the articles I read online offered suggestions for re-purposing some types of plastic bottles which among others included:



1. Using the bottom of a 2-liter bottle which has 5 or 6 bumps on the bottom, coat the bumps with paint, and press them lightly onto a sheet of paper or card stock to create petals for flowers. Add finishing touches of centers, stems, leaves, etc. to create custom greeting cards.

2. Make a chia pet from the bottom half of a 2-liter bottle by gluing features (googly eyes, nose, mouth, etc.) to the outside of the bottle. Fill the interior with potting soil and plant with fast growing grass seeds. This would make a fun project to do with small children as they watch for the hair that will grow on their "pet". Don't forget he will need a hair cut at some point.

Use your imagination, I'm sure there more fun craft projects you can do for yourself or your children using items you might otherwise toss into the trash. Remember the slogan "Reduce, Re-use, and Recycle". It makes good sense, it saves money, and it helps save our planet.
