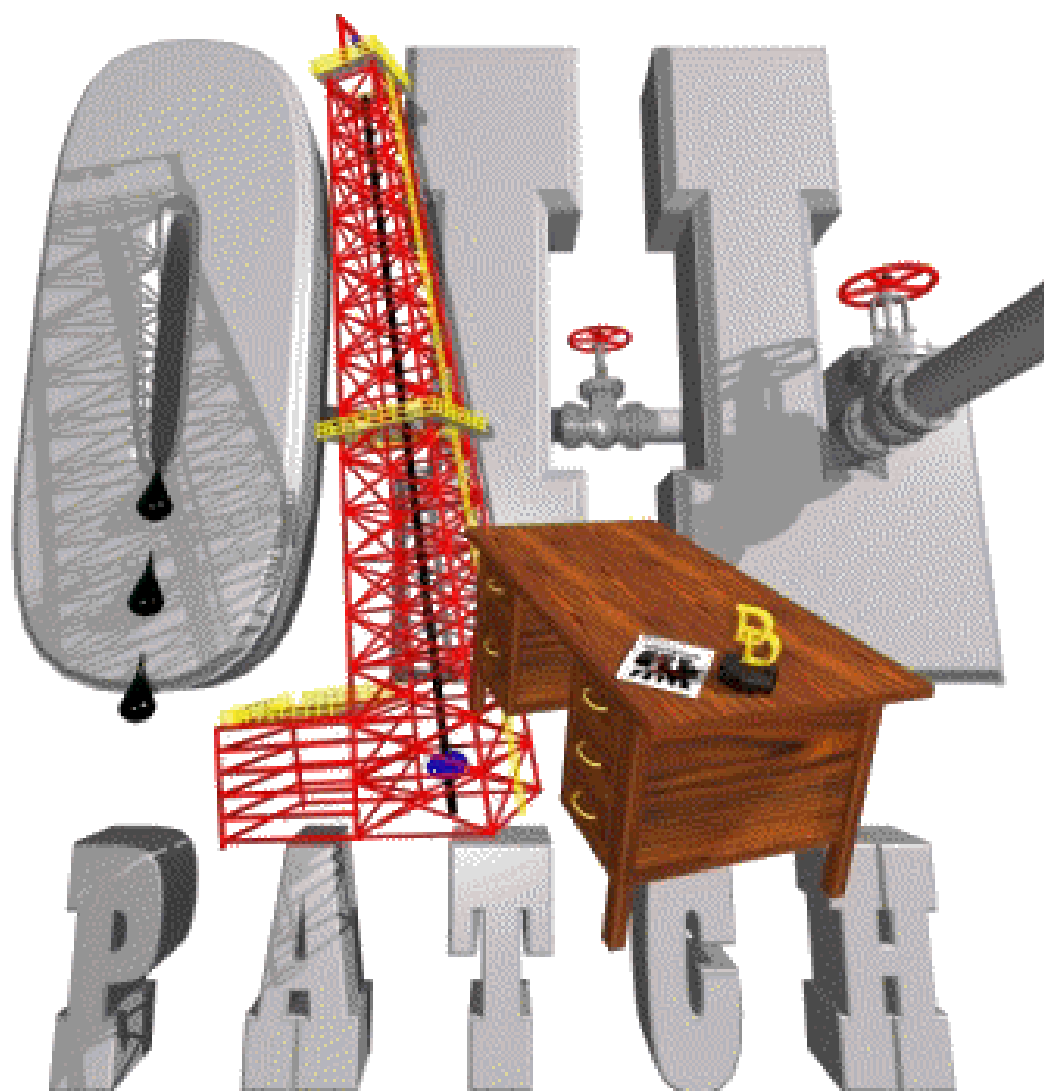

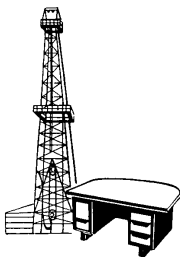

MARCH 2023

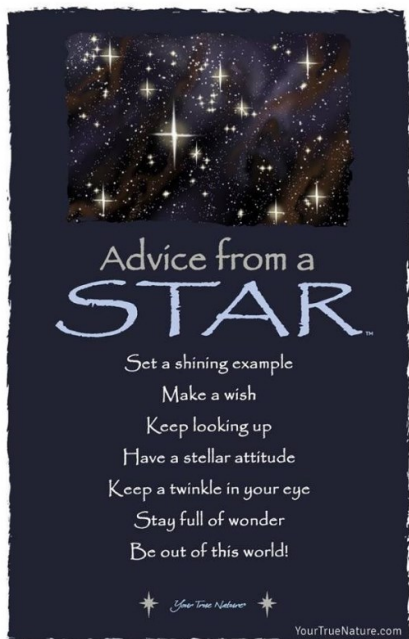

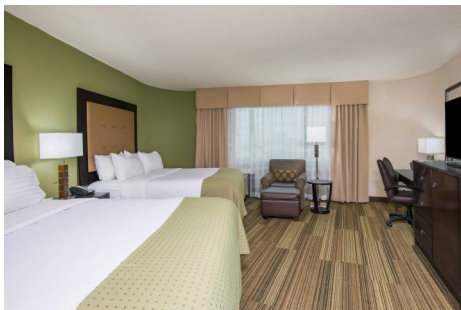

Club and Region Bylaws: Clubs are required to follow Section II. Bylaws in the Club General Information Section of ADDC Bylaws:

II. Bylaws

B. Region and Club Bylaws shall be submitted according to the Club Bylaws Review Committee guidelines at least once every four (4) years per the committee's guideline procedures and Exhibit E, Bylaws Review Schedule spreadsheet.

C. Clubs shall not be eligible to have a voting delegate at any Association meeting (Region or Convention) until the Club Bylaws Review Committee Chairman has confirmed compliance.

Congratulations!! There are NO clubs or regions that are not in compliance with the ADDC Bylaws.

The 2023 deadline to submit bylaws scheduled for review this year is August 30, 2023. All clubs that are due to be reviewed in 2023 will be considered delinquent if they do not submit their bylaws by the deadline. Delinquent clubs may be ineligible to have a voting delegate at ADDC Convention in September.

Attached file Exhibit E shows current status of each club by region. If any club is listed incorrectly, please let me know and it will be corrected, if appropriate. Clubs scheduled for review after 2023 can send your current bylaws (which will be modified ONLY to change format to ADDC standard format) to be posted on the ADDC website. Attached file Exhibit A must be completed and submitted with all club bylaws sent for review.

Clubs listed with "Pending" status should contact me so we can finalize them and have them posted on the ADDC website.

The committee's 2023 goal is to have every club's most current bylaws reviewed and/or posted to the website. We have some catching up to do this year, but we are confident that all bylaws will be reviewed and posted on the website before the year is over.

Recent Energy HeadlinesFebruary 2023 Recap

2/16/2023 - Shell starts production at Vito in US Gulf of Mexico - Shell Offshore Inc., a subsidiary of Shell plc (Shell), announced that production has started at the Shell-operated Vito floating production facility in the US Gulf of Mexico (GoM). With an estimated peak production of 100,000 barrels of oil equivalent per day, Vito is the company's first deep-water platform in the GoM to employ a simplified, cost-efficient host design. 2/14/2023 - Biden to Sell 26MM More Barrels From Strategic Oil Reserve - The Biden administration plans to sell more crude oil from the Strategic Petroleum Reserve, with deliveries estimated to happen between April and June. The non-emergency sale will amount to 26 million barrels of crude, according to people familiar with the matter, and is part the congressionally mandated sale lawmakers approved years ago for the current fiscal year. 2/13/2023 - Kennedy backs bill to return more offshore energy revenue to Louisiana, Gulf states - Sen. John Kennedy (R-La.), Sen. Bill Cassidy (R-La.) and Sen. Sheldon Whitehouse (D-R.I.), along with a bicameral, bipartisan group of lawmakers, introduced the Reinvesting in Shoreline Economies & Ecosystems (RISEE) Act. This legislation would reform the Gulf of Mexico Energy Security Act (GOMESA) to lift a current revenue cap that unfairly penalizes Louisiana, Texas, Mississippi and Alabama. [Read Full Article](#)

2/9/2023 - Louisiana slams EPA over lack of urgency on carbon-project approvals - The U.S. Environmental Protection Agency (EPA) is moving too slowly to allow states to permit and oversee carbon-reduction projects, according to Louisiana's governor, slowing millions of dollars in investments designed to tackle greenhouse gas reduction. Louisiana and other top oil-producing states say they can speed up permitting of carbon sequestration projects if allowed to handle decisions that currently fall under the EPA. There are dozens of these projects with multi-million dollar price tags proposed by energy firms around the United States. [Read Full Article](#)

2/7/2023 - Gulf of Mexico deepwater discoveries survey shows slight decline - Operators announced three new discoveries in the deepwater Gulf of Mexico over the past twelve months, representing a decrease as compared to the five deepwater discoveries reported in 2022. While that decrease may be seen as marginal, the overall number of deepwater discoveries is down significantly in recent years, as compared to the amount seen 20 years ago. In 2003, for example, there were 17 discoveries recorded in the deepwater Gulf of Mexico. That lower level has been driven no doubt by two low oil price shocks in recent years, which in turn has led to lower levels of investment and drilling. [Read Full Article](#)

Shell starts production at Vito in US Gulf of Mexico

15 FEB 2023

Shell Offshore Inc., a subsidiary of Shell plc (Shell), announced that production has started at the Shell-operated Vito floating production facility in the US Gulf of Mexico (GoM). With an estimated peak production of 100,000 barrels of oil equivalent per day, Vito is the company's first deep-water platform in the GoM to employ a simplified, cost-efficient host design.

"Vito is an excellent example of how we are approaching our projects to meet the energy demands of today and tomorrow, while remaining resilient as we work toward achieving net zero emissions by 2050," said Zoe Yujnovich, Shell's Upstream Director, adding, "Building on more than 40 years of deep-water expertise, projects like Vito enable us to generate greater value from the GoM, where our production has amongst the lowest greenhouse gas intensity in the world for producing oil."

The Vito development is owned by Shell Offshore Inc. (63.11% operator) and Equinor (36.89%). In 2015, the original host design was rescoped and simplified, resulting in a reduction of approximately 80% in CO₂ emissions over the lifetime of the facility as well as a cost reduction of more than 70% from the original host concept.

Vito also serves as the design standard for our Whale project that will feature a 99% replication of the Vito hull and 80% of Vito's topsides.

Shell's Powering Progress strategy to thrive through the energy transition includes increasing investment in lower-carbon energy solutions, while continuing to pursue the most energy-efficient and highest-return Upstream investments.

- Originally discovered in 2009, the Vito field spans four Outer Continental Shelf (OCS) blocks in the Mississippi Canyon and is located at a depth of more than 4,000 feet (1,220 metres) of water. The host is located approximately 150 miles (241 kilometres) southeast of New Orleans and 10 miles (16 kilometres) south of the Shell-operated Mars TLP.
- Shell announced a final investment decision (FID) on the Vito project in April 2018.
- Vito is a four-column semi-submersible host facility with eight subsea wells (31,000 feet or 9,400 metres) with deep (18,000 feet or 5,500 metres) in-well, gas lift, and associated subsea flowlines and equipment.
- Vito will produce into Shell Midstream's Mars Pipeline system.
- The Vito field includes leases subject to the Gulf of Mexico Energy Security Act of 2006, which share lease revenues with Gulf producing states and the Land & Water Conservation Fund for coastal restoration projects.
- Current estimated recoverable resource volume of the primary Vito development is 290 million boe. The estimate of resources volumes is currently classified as 2p and 2c under the Society of Petroleum Engineers' Resource Classification System.
- The estimated peak production and current estimated recoverable resources presented above are 100% total gross figures.
- Vito is Shell's 13th deep-water host in the Gulf of Mexico.
- Shell reached an FID on Whale in 2021 and is currently scheduled to begin production in 2024.
- The reference to our US Gulf of Mexico production being among the lowest GHG intensity in the world is a comparison among other IOGP oil-and gas-producing members.
- Shell is the leading operator in the US Gulf of Mexico for oil and gas production.
- In addition to operations in Brazil and the US Gulf of Mexico, Shell's deep-water portfolio includes our Argentina Shales organization and frontier exploration opportunities in Mexico, Suriname, Sao Tome & Principe, Argentina and Namibia.

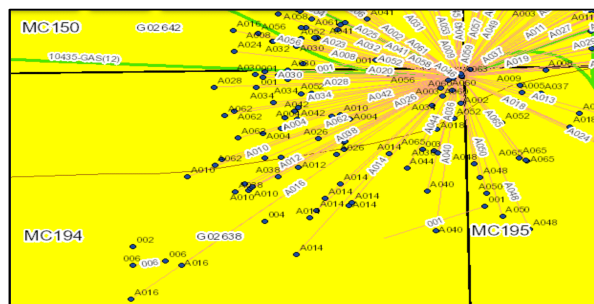
