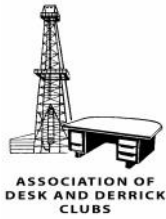

*Our next community service project will be in July when we will be collecting school supplies for a local school. Reminders will be sent as we get closer to the July meeting.*

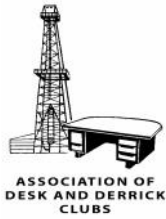

***President:*** *The President shall sign all checks jointly with the Treasurer or the Vice President and shall perform such additional duties as may be required of the office. ## RED RIVER DESK AND DERRICK CLUB

### MAY 23,2023 MEETING

Red River celebrated Industry Appreciation and Advisor Night May 23, 2023. We also gave our Phyllis B. Powell Scholarships to five deserving students from Louisiana Tech University.

Mr. Tanner Watson with Louisiana Oil and Gas Association (LOGA) was our guest speaker to give us a State of the Industry report. The President of LOGA was not able to attend at the last minute and Mr. Watson, Communications Director graciously accepted. Mr. Watson shared a State Report, in which he gave a national and local breakdown of Louisiana's oil and natural gas landscape. The Haynesville Shale, the crown jewel of Louisiana production, is the third-largest gas play in the country. Currently there are 29 rigs operating on the Louisiana side of the Haynesville.

The offshore market has been impacted by the approach to issuing new lease sales, which can have devastating effects on future production. Coastal lawsuits have decimated the South Louisiana landscape, which has only seven rigs currently operating, five of which are on land and two are in the inland waters.

Where do we go from here? One thing is for sure, our livelihood is dependent on the commodity price.

Each May we recognize our Advisors and Laura Hatcher, Advisor Chairman had our Advisor's in attendance to stand and be recognized, Mark Heacock, Heacock Investments, Tim Nielsen, TMPER, LLC., Louise Pearce, Attorney at Law, Jim O' Bannon, Plains Marketing, and Robert Stroud, Stroud Production Inc. Those that were not in attendance and were also recognized are, Rick Hailey, Pinnacle Operating Co., Greg Hall, Chippewa Investments, LLC., John Harrell, Geological Drafting, Neil Havard, Universal Wellhead, Larry Hock, Petro-Chem Operating, Co., Dickie Jester, Retired, Jonathan Matkins, Dobbs Peterbilt, Kevin Moore, Fleaux Services, and Steve Moran, Brammer Engineering, Inc

These gentlemen help us throughout the year with speakers, seminars and our fundraisers for our Scholarship Program.

Bobbie Trust, Dorothy Semon and guest, former club member, Phyllis B. Powell, who our scholarship is named, handed out certificates to the two out of five that were present for their scholarship. We were able to give a total of \$12,000.00 this year. Our students met the requirements and all are pursuing degrees in the Oil and Gas Industry.

## The Heroes of 2023 Region Meeting

If you know me (well), you know I am extremely busy. I have way too many irons in the fire and I don't want to give up any of them. I say this knowing that there are plenty busier than I and plenty with more complex lives than mine. But since I'm writing this, I can make it about me. So about me, I joined Desk & Derrick in 1993 and went to my first Region Meeting in Hot Springs, AR. I was hooked. Not because of the organization that I was connected to by employment, not because of all the fun that I had during that Region meeting, but because of the women that took me under their wings, embraced my youth to their maturity, and included me on their journey.

To this day, I remember that beginning with the fondest of memories. In my younger years I enjoyed being led and then becoming a leader. Today, since I cannot add another commitment and need to be led, I dedicate this article to those wonderful individuals who constantly step up and volunteer for the many thankless duties and chores so we can gather and reconnect one to two times a year in person.

The 2023 Region Meeting hosted by the Desk and Derrick Club of the Westbank was another reminder of the amount of effort some put into our meetings. A special thank you to the ten to twenty that work so hard for us to be able to just show up and be led.

It began with absolutely wonderful weather in Gretna. Some free time allowed walking on the riverfront and collecting drift wood, eating scrumptious appetizers and a little sightseeing. I opted for the C&C Marine field trip which should be an article all of its own. Inherently curious about many things, the beginning of this field trip made me even more curious as to how in the world does that little boat push that big boat. Of course it was much more extensive than that. Starting in 1997, Tony Cibilich rented 800 feet of dock space, a 5,000 sq. ft shop with one crane and one slip. One day a phone call led to a barge repair and his business took roots and grew. After a couple of years, he moved to a 60,000 sq. ft facility. Hearing much of this story did not tell us about the man telling the story. Tony joined our tour and injected information many times but never boasted he was the reason for all of what we saw. Tony is the one you would see rolling up his sleeves and taking hold of the torch, literally! It was far into our tour that I realized he was the owner. We saw many models of what they've built and still nothing compared to be able to walk the yard, see a barge being brought out of the facility and then being able to tour their latest towboat. The owner of said towboat was present to take delivery and appeared equally fascinated to share his new toy with us. We met the "cook" probably also known as mom to many of the men. She explained that she is on the boat for approximately 28 days cooking and serving. We were given a tour of her quarters along with all others. I'm still thinking AirBnB!

Sitting in the captain's chair was priceless and finding out what was inside the big brown wood box was hilarious...captain's toilet!

We drive along the shores and see industrial buildings, scaffolding, cranes and boats/ships of all nature. But to actually walk and see the work involved was truly an eye opener. Highly recommend.

Another equally satisfying but completely different time in history, was our seminar on the Heroes of Sherwood Forest. Our speaker, Randy Miller shared the story of 42 hero roughnecks who in 1943 traveled into the war torn times of World War II to help Great Britain with its oil production. These men were not recognized by any government and secretly stayed with monks while working 24/7 using their skills and knowledge to increase oil production from 300 to 3000 bbls a day. One fatality occurred which happened because of a slip on the ice. Not a military soldier but answering the call, this man was buried with military honors.

These men returned home with no fanfare or recognition but were finally mentioned at the end of the war and on the back page of a London newspaper for “showing the true grit and spirit of the American oil field worker”. A statue was erected of a rig worker with Lucky Strikes holding a wrench. All names of these men are on the plaque.

Speaking of another hero, many thanks to Susan Miller for leading the 2023 Region Meeting. Dealing with extreme discomfort with a scheduled hip replacement the next week, Susan was a champ. Once again, I was made to feel as an individual and not just a number in an organization.

I had the honor of introducing our 2023 ADDC President, Barbara Pappas. No kidding, there is always more than meets the eye. Quiet, mild mannered but with authority and confidence, Barbara shared her leadership skills in a seminar and what I appreciated the most, was very approachable the entire meeting. She shared that she will be motorcycling to Convention!

Southeast Region Field Trip  
C&C Marine and Repair, LLC**

C&C Marine and Repair, LLC began operations in 1997, on the Harvey Canal with a 5,000 square foot shop and 300 feet of waterfront. They started out by providing general steel repairs on inland barges.

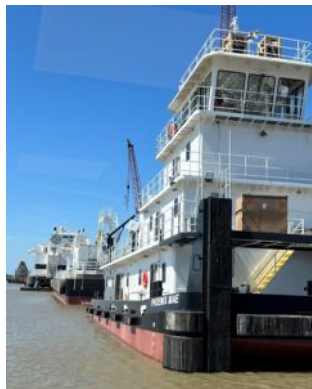
Today C&C Marine and Repair is in Belle Chase, Louisiana, just a few miles from New Orleans. Because of the closeness to both the Mississippi River and Gulf of Mexico this allows them to take on both brown water and blue water projects. Like Barge Fabrication which includes inland tank barges, deck/material barges, spud barges, anchor handling barges. They also build Dredges, Tow Boats and Offshore Supply Vessels.

Their facilities consist of 80 plus acres and 3,200 feet of waterfrontage along the Gulf Intracoastal Waterway. They have ten fully enclosed production and fabrication bays totaling over 500,000 square feet. They use State-of-the-Art shipbuilding equipment. They employ ABS and USCG certified welders, fitters, as well as marine architects, engineers and design professionals.

C&C Marine and Repair also provides a full range of barge repair and painting. Some examples are top-side and hull damage repairs as well as Internal Structural Exam repairs, Hull Re-siding, Barge Blasting and Painting, Bottom Replacement, Piping Repairs and Modifications, Barge Modifications (e.g. splitting, shorten or lengthen, widen or narrow) and Cargo Tank Repairs.

They also have a Robotic Paint & Blasting Facility. They can blast and paint a standard 30,000 Barrel Tank Barge in 7-10 days. They have a fully enclosed, climate-controlled facility that allows for uninterrupted operation, year-round.

At C & C Marine, safety is of the utmost concern. In an effort to minimize accidents, they have safety coordinators and supervisors continually train their employees on safety measures and potential risks and hazards. Because of the they have an exemplary safety record and with minimal incident-related delays.

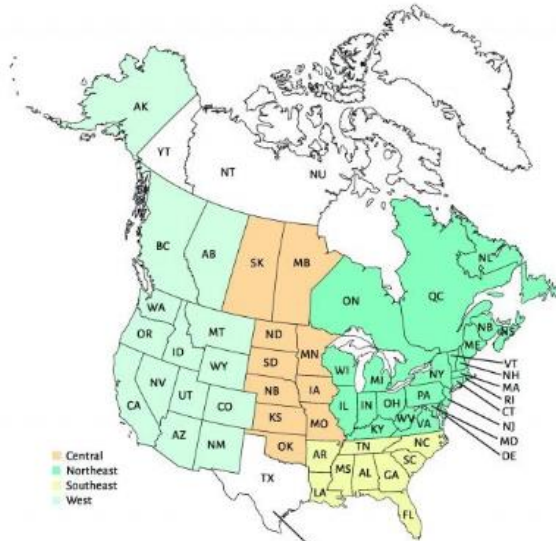
