WHAT IS THE WILLOW PROJECT AND WHY IS IT SO CONTROVERSAL?

Located on the plain of the North Slope of Alaska in the National Petroleum Reserve-Alaska (NPR-A), the Willow Project is an oil drilling project controlled by ConocoPhillips Alaska. The region, about the size of Indiana,



is located less than 30 miles from the Arctic Ocean and is the nation's largest piece of public land. It was designated specifically for oil and gas development by the Naval Petroleum Reserves Production Act in 1976 and is one of the most promising regions in the U.S. for new oil, but it is also a key habitat for polar bears and thousands of migrating caribou and waterfowl.

As the biggest oil project under consideration in the country, ConocoPhillips estimates its cost to be \$8 billion to \$10 billion. Pushing to reduce fossil-fuel consumption as a way to cut emission causing climate change, climate activists have made the project one of their top priorities. ConocoPhillips has held leases for oil development in the region since the late 1990's and discovered Willow with two exploratory wells in 2016. After years of permitting and legal fights and following the recommendations from a government review to keep development out of the yellow-billed loon nesting site and caribou migration paths, on March 13th the Biden administration approved the project going forward with as many as three drilling sites with up to 199 total wells. It is estimated drilling for oil in Alaska's North Slope could produce 500-600 million barrels of oil over the next 30 years delivering over \$17 billion in revenue for federal and state governments as well as local Alaskan communities.

Will the project begin moving forward in the near future? Not necessarily. On March 15th, a coalition of environmental groups filed a lawsuit to overturn Biden's approval of the project. Now what?

According to an article by Tyler Reed in The Shale Magazine there are pro's and con's for the project

PROS:

- **Jobs and Economic Benefits:** The project will create thousand of jobs many of which will draw from the local labor force creating hundreds of direct and ancillary positions as well as boost the local economy. It will also bring in billions in tax revenue for the state and federal governments.
- **Energy Security:** The project would help to increase Alaska's and the U.S.'s energy security by utilizing an untapped source of oil and gas and help to replenish the depleting Strategic Petroleum Reserve.
- **Environmental Benefits:** Both sides agree that the Willow Project is set to be conducted in an environmetally responsible manner.
- **Improved Infrastructure**: The project would include the construction of new roads, pipelines, and other infrastructure improving access to the area benefiting local and national economies.
- Support for Indigenous Communities: Willow Project would provide economic support and cultural-sensitivity for indigenous communities in the area.
 CONS:
- **Environmental damage:** The project involves the construction of roads, pipelines, and other infrastructure through a pristine wildlife habitat. Any form of construction will damage/disrupt local flora and fauna.
- **Air and Water Pollution:** While it may be minimal, a remote drilling facility needs a lot of resources to be built and to operate in an environment as harsh as Alaska. Diesel fuel, chemicals, wastewater, trash, and other contaminants pose environmental risks if not properly disposed.

Tri-State Desk and Derrick April 20, 2023 Minutes



The April meeting of the Tri-State Desk and Derrick Club was held at Kemper, CPA's office on April 20, 2023, with the following members present: Michael Nelligan, Ryan Masterson, Emily VanHaaften, Alesia Cato, Stacee Dover, Karen Chamberlain, Beth Etzkorn, Donna Hartig and Gary Hartig. President Michael Nelligan called the meeting to order at 5:47 PM.

Minutes from the March meeting were not available. Ryan Masterson distributed the treasurer's reports for January, February, and March. Emily moved to accept the treasurer's reports subject to audit. Stacee seconded the motion and it passed unanimously.

Emily announced she has just received a new membership application from Sean Hopf with Countrymark.

Michael reported the club has received ten scholarship applications. The Scholarship Committee last year consisted of himself, Stacee Dover, and Linda Henning. By consensus it was agreed the committee would remain the same for 2023. INOGA has agreed to contribute an additional \$1,000 above its initial contribution of \$2,000 which will be used to increase the amount awarded to the top candidate in 2023. In 2022, Tri-State awarded a total of \$9,000 in scholarships. Ryan moved the club award scholarships in 2023 totaling up to \$10,000 with that total to include INOGA's \$3,000 contribution. The motion was seconded by Emily and passed unanimously. The committee will review the applications by May 12th, and the winners will be announced at the Region Meeting.

The pork loin fund raising event to benefit the scholarship program is tomorrow, April 21st. Currently we have 351 pork loins sold.

As of today, we have received 29 registrations for the Region Meeting indicating plans to book 70 room nights at the hotel against our commitment of 80 room nights. If additional room nights are not booked, the meeting budget will be responsible for the difference of \$1,293.00. The Northeast Region By-Laws specify that should a Region Meeting show a negative balance, the Region Fund will be responsible for the first \$1,000 and the host club will be responsible for any excess. A general discussion followed concerning engaging additional sponsors as the current budget shows a negative balance of approximately \$500.00.

As part of the planned field trip, we will be visiting one of CountryMark's production facilities versus our original destination. There will be no Certification Class as only two members signed up. Those members have the option of taking the Geology Class online.

The May meeting will be held virtually on May 4th at which time, we will iron out details for the Region Meeting. Topics to be addressed include: greeters, registration, goody bags for field trip and speakers' gifts. Emily plans to pick up the snacks and water for the field trip.

Alesia Cato led the members through a tour of the ADDC website using a program she named the "A, B, C's of D&D". Prior to the meeting, members were encouraged to bring their laptop computers so they could follow along as she used the alphabet as a travel map to explore the ADDC website. From locating the site on the internet to finding forms, committee responsibilities and guidelines to finding information about the Association and upcoming events, we came away with a better understanding of how to use the website.

Emily moved the meeting be adjourned at 7:19 PM, Karen seconded it and it was approved unanimously. Respectfully submitted
