SEPTEMBER & OCTOBER CALENDAR OF EVENTS

The demand for crude oil and natural gas around the world has created upward pressure on price even though production is rising.

Crude oil in the U.S. is approaching record levels, outpacing Saudi Arabia and Russia, the other leading producing countries.

The U.S. Energy Information Administration (EIA) expects U.S. crude oil production to surpass 12.9 million barrels per day for the first time in late 2023 and to exceed 13 million barrels per day in early 2024, according to its monthly Short-Term Energy Outlook (STEO) released this week. EIA forecasts U.S. crude oil production to average 12.8 million barrels per day in 2023, which is 200,000 barrels per day more than in its July forecast.

EIA expects sustained global demand for petroleum products will continue to rise.

The Brent crude oil price (which is on the international exchange based in London) was near \$75 per barrel at the beginning of July and increased throughout the month to surpass \$86 per barrel on August 4, EIA stated. EIA forecasts the Brent crude oil price to increase the rest of 2023 and to approach \$90 per barrel in late 2023.

West Texas Intermediate (WTI) traded on the New York Mercantile Exchange generally follows the Brent price but ranges \$3 to \$5 per barrel less than Brent. WTI closed on Wednesday at \$84.

EIA forecasts U.S. regular gasoline prices will average about \$3.63 per gallon for the rest of 2023, an increase from its previous forecast of \$3.27 per gallon.

EIA believes global liquid fuels production will increase by 1.4 million barrels per day (b/d) in 2023 even though Saudi Arabia, the world's largest oil exporter, has reduced production by an estimated I million b/d. Non-OPEC production increases by 2.1 million b/d in 2023, which is partly offset by a drop in OPEC liquid fuels production. In 2024, global production increases by 1.7 million b/d, with 1.2 million b/d coming from non-OPEC countries.

In order for a club to thrive and be successful, member participation is crucial. So, I ask you, what does your role look like next year as a member? We are here to support and guide you throughout the process. *Dr. Suess wrote, "Remember that life's A Great Balancing Act. And will you succeed? Yes! You will, indeed! (98 and 3/4 percent guaranteed). Kid, you'll move mountains."* You've got this! We have faith in you, and we're here every step of the way to help you on your journey.

Here is your September excerpt from Alex Epstein's book <u>Fossil Future:</u> —a double dosage this month concerning two things that are very relevant today—drought and fires.

"Mastering Drought—The number one way in which we use fossil-fueled machine labor to master drought is through irrigation. Irrigated lands average more than three times the crop yields of rain-fed areas. Sometimes irrigation can rely on gravity to move water, but when it can't, irrigation takes a lot of energy—usually fossil fuel energy—to move the water. Irrigation systems are produced by myriad fossil fuel powered machines, such as mining equipment, steel furnaces, and assembly machines. By powering irrigation machines and the machines that produce irrigation infrastructure, fossil fuels enable the empowered world to be unnaturally hospitable to crops even when nature is at its harshest."

"Mastering Fires—In addition to using fossil-fueled machines to reduce fuel load and build barriers to prevent dangerous fires, we use fossil-fueled machines and fossil fuel materials to fight fires when they start. We use high-energy fossil-fueled machines, like trucks and aircraft for transporting water, and flame-resistant, oil-derived materials such as Nomex to protect firefighters. Note: Direct firefighting is only effective if it is part of a broader mastery strategy that includes fuel load reduction and/or barrier building."

We will journey back in time to explore some of the key factors that have shaped this industry and our world. Join us as we uncover the fascinating tales behind this vital industry. 



Charting Your Legacy: Navigating the Waters of Estate Planning An Introduction to Estate & Legacy Planning

Estate planning is the process of making arrangements for the management and distribution of one's assets and properties after their death. It can also be very costly ranging from \$3,500 to \$25,000.

Non-OPEC production growth in the forecast is led by the United States, Brazil, Canada, Guyana, and Norway. EIA said.

Electricity consumption in the U.S. will reach near-record levels of electricity consumption this year. EIA estimates about 388 billion kilowatt-hours of electricity was consumed in the United States during July, about equal to the record for monthly U.S. consumption set in August 2022. Natural gas is the primary fuel used to generate electricity.

Associated natural gas production growth in the Permian Basin, driven by higher oil prices, has supported U.S. dry natural gas production in 2023 despite a decline in natural gas prices. EIA expects production to average about 104 billion cubic feet per day (Bcf/d) through the end of 2024, which will be another production record by the U.S. oil and gas industry.

Record energy production forecast for U.S.

Production of crude oil, natural gas, wind, and solar are expected to set new records in the United States this year, and preliminary numbers indicate each sector is on course.

The Energy Information Administration (EIA) at the Department of Energy released data this week showing U.S. crude oil production averaged 12.5 million barrels per day (b/d) from January to July compared to 11.9 million b/d during the same period last year, the previous record. Add in natural gas liquids for total field production of 18.7 million b/d compared to 17.5 in 2022.

Dry natural gas production from January to May rose to average 15,462 billion cubic feet surpassing the previous record of 14,494 billion cubic feet during the same period in 2022.

Crude oil and natural gas have been net exporters since 2019, meaning the U.S has exported more product than it has imported.

LNG exports from facilities based in Texas and Louisiana continue to grow.

Global liquefied natural gas (LNG) import capacity is set to expand by 16%, or 23 billion cubic feet per day (Bcf/d), by the end of 2024 compared with 2022, according to EIA. In the first seven months of 2023, three countries—Germany, the Philippines, and Vietnam—began importing LNG for the first time. By the end of next year, EIA expects Antigua, Australia, Cyprus, and Nicaragua to start importing LNG.

"Over the past 10 years (2013–22), global LNG import capacity—called regasification capacity—has grown by 49% (45.8 Bcf/d) to reach 140.0 Bcf/d across 48 countries," EIA stated. "By the end of 2024, we expect 55 countries to have LNG regasification terminals with a combined capacity of 163 Bcf/d."

So far this year, fossil fuels account for 79% of the energy mix compared to 13% for renewables and 8% for nuclear.

Wind became the largest energy source in the renewable category in 2019 outpacing hydroelectric power, and it has been growing each year. Wind consumption in the U.S. during the first five months was 1,772 trillion British thermal units (Btu) compared to 962 trillion Btu for hydro-electric. Solar consumption was 826 trillion Btu compared to 743 during the same period in 2022.

EIA believes solar and wind will account for 16% of total generation this year, while coal production will decline from 20% to 18%.

In 2022, solar photovoltaic panel shipments in the United States increased 10% from 2021, setting another annual record (31.7 million peak kilowatts [kWp]), according to EIA. Solar panel shipments have been growing as solar capacity continues to rise.

U.S. solar panel shipments include imports, exports, and domestically produced and shipped panels. In 2022, about 88% of U.S. solar panel shipments were imports, primarily from Asia.

Over the past decade, U.S. solar capacity has boomed, which includes both utility-scale solar farms (with one megawatt of capacity or more) and small-scale solar, according to EIA. The majority of small-scale solar is residential rooftop solar installations.

Petroleum prices rise as supplies tighten

Crude oil, gasoline and other petroleum prices continued to rise this week as global and U.S. supplies became tighter.

West Texas Intermediate closed at \$87 per barrel on Wednesday. Brent crude oil, which is traded internationally, hit \$90 this week.

Gasoline and diesel prices also rose. The average price for a gallon of gasoline in the U.S. was \$3.80 compared to \$3.37 in Texas, according to AAA. Diesel average \$4.452.

Many analysts believe the recent decline in oil supplies from Saudi Arabia and Russia, two of the largest oil producing countries, is a major reason for the rising prices as demand remains strong.

Saudi Arabia reduced production by one million barrel a day, which is roughly 10% of its previous production, in July and said this week it will extend the cuts for the remainder of 2023.

Russia extended its voluntary decision to curb crude exports by 300,000 b/d until December 2023, acting in concert with Saudi Arabia, with the stated aim of maintaining stability and balance in the oil markets. Russian seaborne crude and product exports fell to their lowest since September 2022 as strong domestic demand in the summer kept volumes available for external markets capped.

Even though Saudi Arabia and Russia have reduced oil supplies globally, U.S. oil production continues at a record setting pace of 12.5 million barrels per day. However, crude oil and gasoline stocks in the U.S. have declined about 10% since the beginning of the year.

Refinery outages and capacity constraints are making refining account for a larger share of the overall cost of gasoline than in the past, according to the Energy Information Administration's Gasoline and Diesel Fuel Update.

As of July 2023, refining (the difference between refiners' crude oil acquisition costs and wholesale gasoline prices) accounted for an average of 22% of the overall gasoline retail price for the first seven months of 2023 compared with the five-year (2018–22) average of 15%. This change means that even though crude oil prices have declined from last year's high, retail gasoline prices have remained higher than they historically would because of increased costs for refining, EIA stated.

EIA expects recently announced maintenance of refineries in Pennsylvania and New Brunswick, which have a total capacity of about 500,000 barrels per day, will be offline until November.

Low US distillate inventories could make heating oil prices be susceptible to sudden shocks this winter as stocks of diesel and heating oil remain 15% below five-year average rates, at 118 million barrels or 31 days of supply, according to OilPrice.com.

RRC Submits Comments on Proposed EPA Rules that Could Stifle Reliable Energy to Protect Texans

AUSTIN - The Railroad Commission of Texas (RRC) and the Texas Commission on Environmental Quality (TCEQ) submitted joint comments opposing the EPA's proposed rule that would add regulations to fossil fuel-fired electric generating units in attempts to decrease carbon dioxide (CO2) emissions.

The likely outcome of this rule could result in the elimination of coal-fired units and a reduced ability to operate natural-gas fired power plants, which are critical for electricity supply in a state experiencing a booming population like Texas.

The comments also detail the unrealistic assumptions and artificially high metrics EPA used to estimate the climate benefits of the rule. Additionally, the supplemental costs involved, along with the additional infrastructure that would be necessary to implement the proposed requirements, would impose unreasonable costs in comparison to the anticipated benefits, all while placing reliable fuel supply for the electric grid at risk.

"The EPA continues to undermine the needs of Americans," said RRC Chairman Christi Craddick. "The latest proposed rule is unrealistic and potentially dangerous as it reduces or eliminates access to electricity for consumers. During extreme heat waves, like we are currently experiencing in Texas, and extreme cold snaps, access to power from natural gas and coal is critical for survival. I am proud to join with TCEQ and push back against these outrageous proposed regulations."

"President Biden's obsession with 'net-zero' is propping up unreliable energy sources that only make our electric grids unstable and leave consumers with higher energy costs," said Commissioner Wayne Christian. "In May, the Public Utilities Commission of Texas and the Federal Energy Regulatory Commission warned that the retirement of thermal-based energies is leaving our grids extremely vulnerable to power blackouts, and this decision will only lead to less investment in those sources and less reliable energy on our grids."

"Our state and our nation are at a crossroads when it comes to the future reliability of the electric grid. Unfortunately, the EPA's proposed rule will send us further down the path of less dependability and higher consumer costs," said Commissioner Jim Wright. "Since 2000, the population of Texas has increased by 43% and our economy has grown by 88%, yet we've added only 18% more dispatchable generation to our electric grid. The EPA's short-sided approach will only serve to further disincentivize investment in reliable electric generation and reduce our ability to provide electricity when it is needed most."

A final rule from the EPA is expected in early 2024.
