

This year was busy for the 2023 ADDC Board and we voted on 50 items of business this year. The 2022 FRC is completing their review of the 2022 ADDC Financials and hopefully will be sent to membership soon. The 2023 FRC is finishing up the 3<sup>rd</sup> quarter and will send out to membership this month, and the 4<sup>th</sup> quarter 2023 financials will be sent out by March 2024.

I would like to say "Thank You" to the 2023 ADDC Board for all their hard work, determination, and perseverance in making ADDC better than the year before. That is how we grow. #### Energy prices decline as supply increases

The price of crude oil, natural gas, and gasoline has dropped more than 10% in recent weeks, but the U.S. Energy Information Administration (EIA) believes higher prices are in the future even though several economic indicators create questions.

West Texas Intermediate crude has declined 13% since November 2022 to average \$80 per barrel so far in November compared to \$92 last year, according to EIA. WTI closed at \$75.65 on Wednesday.

The national average for retail gasoline has followed suit declining from \$3.804 per gallon in November 2022 to \$3.405 this week, which is an 11% decline, according to AAA. The average price in Texas this week was \$2.871, which is 10% less than last year. Many locations across Texas reported retail gasoline prices as low as \$2.61 on Wednesday.

Natural gas witnessed the largest decline this year of 49%. Natural gas traded on the spot market at Henry Hub in November 2022 averaged \$6.40 per million British thermal units (mmBtu) compared to \$3.264 this year. Natural gas closed at \$3.12 on Wednesday.

"We forecast the Brent crude oil price will increase from an average of \$90 per barrel (b) in the fourth quarter of 2023 to an average of \$93/b in 2024," EIA said its Short-Term Energy Forecast released this week.

"Although the conflict between Israel and Hamas has not affected physical oil supply at this point, uncertainties surrounding the conflict and other global oil supply conditions could put upward pressure on crude oil prices in the coming months," EIA stated.

EIA believes U.S. gasoline consumption declines by 1% in 2024, which would result in the lowest per capita gasoline consumption in two decades. "An increase in remote work in the United States, improvements in the fuel efficiency of the U.S. vehicle fleet, high gasoline prices, and persistently high inflation have reduced per capita gasoline demand," EIA stated.

"We forecast U.S. natural gas inventories will end the winter heating season (November–March) 21% above the five-year average with almost 2,000 Bcf in storage," EIA said. "Inventories are full because of high natural gas production and warmer-than-average winter weather, which reduces demand for space heating in the commercial and residential sectors. We forecast the Henry Hub spot price to average near \$3.20 per million British thermal units (MMBtu) in November, down from a price of almost \$5.50/MMBtu a year earlier."

However, the record oil and natural gas production in the U.S. this year has created large inventories and EIA projects the records being set in 2023 will be broken in 2024. When supplies out pace demand prices will drop.

Exploration and production companies will respond by reducing drilling operation. Already the drilling rig count in Texas and the U.S. is off 19% from last November.

#### Wind and solar experience growing pains

As wind and solar energy continue their quest to become major players in the energy production game, each face stiff head winds as financing and equipment costs rise and inflation eats away at the bottom line.

The Wall Street Journal reported this week about presentations of executives during the Super-Return Energy Conference in New York that revealed some companies that invest in energy projects are wondering about the profitability of wind and solar projects.

"The irrational exuberance, all the excitement about clean energy, is clearly getting squeezed out" of a market than can no longer afford it, said David Foley, a senior managing director at Blackstone who leads the asset managing group.

The stock indexes tracking clean energy companies have dropped significantly recently, Foley said, making it more challenging for companies to raise capital and secure financing.

The financial problems have investors concerned that the long-term contracts negotiated previously will not cover the rising costs.

Siemens Gamesa, a German company that is a leading developer of offshore wind projects, canceled plans to build blades for offshore wind turbines in Virginia. Siemens Gamesa said the Virginia project was canceled because "development milestones... could not be met." The company previously had acknowledged that its blades did not meet company standards and had to be replaced quicker that previously guaranteed.

One obvious solution is to charge more for the power generated. However, long -term contracts present a problem if there is no consideration for price escalation.

The WSJ reported electricity-price volatility is a common hurdle for developers.

"Investors and developers that have the purview of the (clean energy) food chain are going to be better placed to reduce inefficiencies in the system than people just taking one distinct piece," Himanshu Saxena, chairman and chief executive of Lotus Infrastructure Partners, stated during a panel discussion. "That business is going to get harder because you need to be able to control more pieces to make the numbers work."

Higher project costs force government agencies and commercial consumers to recognize the reality that output prices must generate returns for investors in the green-energy infrastructure they are financing, the WSJ reported.

Wind and solar have increased, but have a long road ahead to equal other energy sources. Wind generated 7% of the electricity in the U.S. in August compared to 6% in August 2022, according to the Energy Information Administration. Solar also increased 1% from 3% in August 2022 to 4% this August. Natural gas generated 47% this year up from 46% in 2022. Coal had the largest decline dropping from 21% in 2022 to 18% this August. Nuclear generated 16% in August 2022 and 2023.
