This year was busy for the 2023 ADDC Board and we voted on 50 items of business this year. Oil and Gas Technology Helping to Create Clean Energy

Several years ago, Gary and I installed a geothermal heating and cooling system in our house. The temperature of the ground in our area just a few feet below the surface remains at a constant temperature of about 55 degrees Fahrenheit year around. A geothermal system uses small-diameter, High-Density Polyethylene (HDPE) pipes buried underground called a "loop." The loop circulates water to the unit in the house picking up the 55° ground temperature along the way. The unit in the house heats it to the desired temperature to either heat or cool the air in the house. Air conditioning is great, but I wouldn't want the house to be at 55°. That means the air in the house needs to be heated even in the summertime.

But what about the temperature of the earth at greater depths? According to Britannica's website, heat from the Earth's interior generates surface phenomena such as lava flows, geysers, fumaroles, hot springs, and mud pots. This heat is produced mainly by the radioactive decay of potassium, thorium, and uranium in the Earth's crust and mantle and also by friction generated along the margins of continental plates.

As reported by the U.S. Energy Information Administration, the United States leads the world in using the Earth's heat energy for electricity generation, but geothermal still accounts for less than half a percent of the nation's total utility-scale electricity generation. In 2022, that geothermal power came from California, Nevada, Utah, Hawaii, Oregon, Idaho, and New Mexico. Those are states traditionally thought of as having geothermal potential because of the reservoirs of steam or very hot water close to the surface. However, Energy Secretary Jennifer Granholm said earlier this year that advances in enhanced geothermal systems will help introduce this form of energy in regions where it's been thought to be impossible.

Using relatively new technology developed during the shale boom and working with Google (yes, that Google), Houston-Based Fervo Energy has developed an advanced geothermal project which has begun pumping carbon-free electricity onto the Nevada grid to help power Google's data centers in the state. Google needs more power than is currently being produced by this project so they are also investing in solar and storage. In 2020, Google announced that by 2030 it would use carbon-free energy every hour of every day, wherever it operates.

For the project in Nevada, Fervo drilled some 8,000 feet down, turned sideways and drilled about 3,250 feet horizontally. Just like in hydrocarbon horizonal wells, Fervo is able reach much more of the hot reservoir, versus having to drill many vertical wells. Cold water is pumped down an injection well, then over/through hot rock underground to the production well. The path between the wells is created by fracking or fracturing the rock. On its journey, the water heats up to nearly 400 degrees Fahrenheit (200 degrees Celsius) before returning to the surface. Once there, it transfers its heat to another liquid which has a low boiling point to create steam. The pressure of the steam's expanding spins a turbine to produce electricity like in a coal or natural gas-fired plant. The geothermal water, now cooled, is put back down the injection well to start the cycle again in a closed-loop system.

That's not exactly how our geothermal system works, but the basic concepts are very similar.
