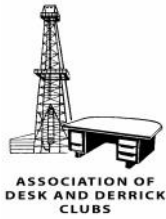

Returned checks will be subject to a fee of \$75.00 US.

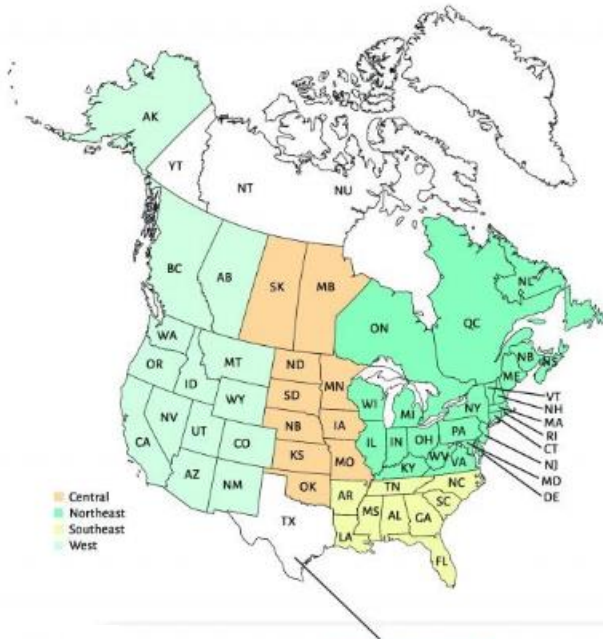

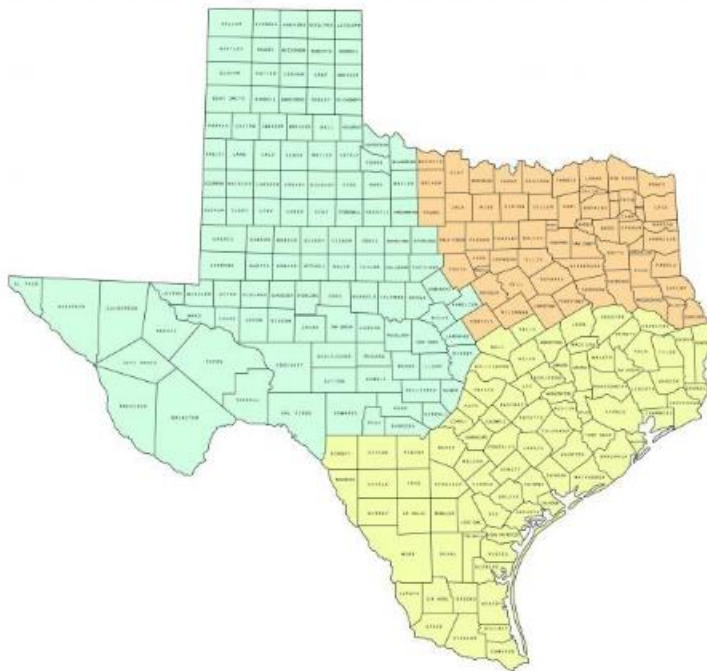
