## **Biomass Energy Not Necessarily Good for Everyone**

Humans have used biomass energy (energy from living things) ever since they discovered fire to warm their bodies and cook their food. Exactly what is biomass? Biomass is organic, meaning it is made of material that comes from living organisms, such as plants and animals. The most common biomass materials used for energy are plants, wood, and waste, all of which are called biomass feedstock.

One growing use for biomass in the U.S. is the production of wood pellets some of which are used in BBQ grilling and home heating, but the pellets are primarily produced for export to Europe as a replacement for coal. After the European Union classified biomass as renewable energy in 2009, the U.S. Southeast's annual wood pellet capacity increased from about 300,000 tons to more than 7.3 million tons by 2017, according to research led by a University of Missouri team.



Producing an alternative energy source from waste generated from tops of trees and leftovers from lumber production and paper mills includes a process where the ground wood fiber is heated to make it secrete lignin, which is used as its natural binding agent. Under pressure, the gluey mass is forced through small holes (somewhat like a garlic press) to form the pellet shape. Ultimately, the pellets are dried out so completely that they lose the ability to absorb moisture, or rot and making them economically viable for shipping long distances.

Creating jobs and revitalization in small, disadvantaged communities while converting waste into an alternative energy source sounds like a win-win situation, but not so much for the people living in close proximity to the processing plants. A July 27th article in the Los Angeles Times by James Pollard, Julie Watson and Stephen Smith suggests these facilities are damaging the life and health of the rural southern, predominantly black communities, where they are being located. Interviews with residents of towns with large black populations, from Gaston, N.C., to Uniontown, Ala., surfaced complaints of truck traffic, air pollution and noise from pellet plants. Gloster, Mississippi, has become the poster child for such tensions. According to an Environmental Protection Agency mapping tool, Gloster is exposed to more particulate matter than much of the U.S. and adults living there have higher asthma rates than 80% of the country. So much for being a good neighbor!

The use of biomass in the form of wood pellets is touted as being a renewable energy, but it takes years for newly planted trees to replace those being cut now. In addition, old growth trees remove considerably more carbon dioxide from the atmosphere than trees planted to take their place. Scientific studies have found firing wood pellets puts more carbon immediately into the atmosphere than coal, and according to a 2023 paper in the journal "Renewable Energy", pollution from biomass-based facilities is nearly three times higher than that of other energy sectors.

In a 2018 letter signed by 796 scientists addressed to the UE Parliament regarding forest biomass, they warned the EU that "placing an additional carbon load in the atmosphere for decades means permanent damages due to more rapid melting of glaciers and thawing of permafrost, and more packing of heat and acidity into the world's oceans. The letter goes on to say: "The adverse implications not just for carbon but for global forests and biodiversity are also large. More than 100% of Europe's annual harvest of wood would be needed to supply just one third of the expanded renewable energy directive. Because demand for wood and paper will remain, the result will be increased degradation of forests around the world. The example Europe would set for other countries would be even more dangerous. Europe has been properly encouraging countries such as Indonesia and Brazil to protect their forests, but the message of this directive is "cut your forests so long as someone burns them for energy."
