

"A Christmas Story" with Ties with the Oil Industry

Every year at Christmas time we have the opportunity to spend an entire day watching a marathon running of the 1983 movie "A Christmas Story" with the warning that if we get a Red Ryder BB gun for Christmas, we could shoot our eye out. It's such a classic that many of us can recite the lines just as they are running on the screen. But did you catch some of the ways petroleum products are featured in the movie beginning with early in the movie when Ralphie sports a set of paraffin fangs to entertain his 4th grade classroom—although not necessarily the teacher.

Beginning with the first commercial U.S. oil well drilled in August 1859, Pennsylvania oilfields quickly brought an important new source for illumination to the public called

kerosene. Kerosene could be produced at about a fifth the cost of the cheapest candles as well as it presented a reduced fire hazard. An important by-product of kerosene distillation called paraffin quickly found its way from the refinery to the marketplace in the form of candles, sealing waxes and chewing gums as well as in a host of novel uses.



In addition to the gorgeous, bright red, wax lips popular with the girls, various confection companies utilized paraffin to produce novel confections such as fun gum, sugar lips, wax fangs, and small wax bottles filled with colored syrup called Nik-L-Nips. You could "uncap" the bottle, drink the syrup, and then chew on the paraffin bottle for a few minutes.

Concord Confections, part of Tootsie-Roll Industries, continues to produce wax lips and other paraffin candies for today's generations of schoolchildren. I don't want to forget to mention one of the more important and useful products derived from paraffin is the still popular crayons used by schoolchildren and adults everywhere.

Getting back to "The Christmas Story", the most memorable waxy petroleum product featured in the film is the polymer "major award". Who can forget the legendary plastic 3-foot-tall, flesh-colored leg encased in a risqué black nylon fish net stocking and anchored in a black plastic stiletto heel. After prying open the shipping crate, remember how "the old man" ecstatically tried to insert the lamp's plastic electric plug into the wall socket already overloaded with multiple RE CHO WY

plugs and extensions and the sparks that ensued? This iconic petroleum product is even featured in a current commercial for Wayfair and is available for sale on the internet in various sizes priced from \$20,000 to \$78.99. You might even be interested in a Christmas ornament-size lady leg lamp for \$9.99


Most people won't recognize how many petroleum products are featured in the film (not to mention the film itself), but I hope the next time you watch "The Christmas Story" you will.

Hey! What's "UP" ?

Whenever Gary is asked what he's up to, he generally answers "About 6 feet 6 inches". If you ask a four year old that same question, their simple honesty in answering the question might cause you to laugh or could even cause you to feel a bit uncomfortable.

This simple little two-letter word can mean so many different things it is one of the words which cause non-English speaking people to think the English language is exceptionally confusing and difficult to understand.

Here's a few examples of that premise:

Why are the officers UP for election, and the secretary needs to write UP a report? We call UP our friends, and we brighten UP a room and sometimes polish UP the silver.

We warm UP the leftovers and clean UP the kitchen. We lock UP the house, and some guys fix UP old cars.

Sometimes the little word "UP" has a real special meaning:

People stir UP trouble, line UP for tickets, work UP an appetite and think UP excuses.

To be dressed is one thing, but to be dressed UP is special. A drain must be opened UP because it has been stopped UP. We open UP a store in the morning and close it UP at night.

We seem to be pretty mixed UP about "UP". To be knowledgeable about the proper uses of "UP", look the word UP in the dictionary. In a desk-sized dictionary, it takes UP almost a quarter of the page and can add UP to about thirty definitions. If you are UP to it, you might try building UP a list of the many ways "UP" can be used. It will take UP a lot of your time, but if you don't give UP, you may wind UP with a hundred or more.

When it threatens to rain, we say it is clouding UP. When the sun comes out, we say it is clearing UP. When it rains, it wets the earth and often messes things UP. When it doesn't rain for a while, things dry UP.

I could go on and on, but I'll wrap it UP. For now, it is time to shut UP. I hope you've enjoyed this little exercise in the uses of the word "UP"; but more than that, I hope this sheds a little light on why some people think it is hard to understand what we take for granted when we speak or write in the American version of English.
